\*In response to the COVID-19 crises, on March 18, 2020, Governor Brad Little issued a proclamation suspending the portion of Idaho Code 74-203(5) which requires government agencies to allow the public to attend public meetings in person and requires at least one member of the governing body or administrative officer of the body to be physically in attendance. The purpose of the proclamation was to allow public business to be conducted while also following guidance to limit gatherings to 10 or fewer people. The proclamation confirmed governing agencies of public bodies should allow for public attendance using telecommunication devices at public meetings. The proclamation and suspension of these rules may expire prior to the date of this meeting. On May 1, 2020, the Governor issued the Stay Healthy Order allowing businesses and governmental agencies to resume operations at physical locations in the state of Idaho except for businesses identified in the Order. The May 1, 2020, Stay Healthy Order rescinded the Stay-Home Order dated March 25, 2020, and as subsequently extended, but did not rescind the March 18, 2020, Proclamation. This meeting is tentatively scheduled to occur during Stage 2 of Opening Up Idaho; however, whether the criteria is met to support transition from Stage 1 to Stage 2 is unknown at the time of posting this Notice and Agenda. Social Distancing and Sanitation Requirements continue to be in place. Under Stage 2 gatherings, both public and private, of less than ten people where appropriate physical distancing and precautionary measures are observed can occur. The District may allow for a very limited number of board members and staff in attendance, though all will be encouraged to attend remotely. The doors will be open to the public but alternative methods of participation are still highly encouraged. Because of the physical limitations of the meeting space, any attendance may still be limited to less than ten persons in attendance at any one time and following social distancing recommendations. If you attend in person, you may be asked to remain outside the meeting room until the agenda item you are interested in is under consideration.
